



Joint industry position on Amending Regulation (EU) 2023/1542 as regards obligations of economic operators concerning battery due diligence policies

Executive summary

FEM, the European Materials Handling Federation, and EGMF, the European Garden Machinery Federation, support the European Commission's proposal 2025/0129 amending Regulation 2023/1542 as regards obligations of economic operators concerning battery due diligence policies.

This amendment addresses the uncertainty that companies are experiencing and creates the enabling conditions for fulfilling the due diligence and conformity assessment requirements. However, it does not tackle one of the key root causes, that is, the lack of an alignment between the establishment of harmonised standards for accreditation and the newly introduced enforcement deadline.

Insights

The postponement of the legal deadline for demonstrating compliance with the due diligence obligations by two years is welcomed and supported. The extension for the date of the publication of the European Commission's implementation guidelines is a necessity given the absence of progress in this regard.

Having considered the missing guidance and there being yet no notified bodies being accredited, FEM and EGMF further propose a two-stage approach being implemented for the due diligence requirements. During the first stage, economic operators would be able to conduct their due diligence processes on the basis of self-declaration, followed one year later by the obligation to obtain third-party verification.

The Commission's proposal acknowledges that the delay can be ascribed to the lack of determination of a standard for the notified bodies for battery due diligence by the European cooperation for accreditation association (EA). The proposed additional period would allow for a practical implementation not only by the economic operators but also for EA to develop and publish the relevant standard, as well as for the notified bodies to apply for accreditation

from their national bodies, and undertake the necessary evaluation and awarding by their accreditation service.

Recommendations

FEM and EGMF, therefore, suggest the following amendments to Article 1:
